I will not ride or be on site without signing and acceptance of this waiver. I knowingly assume all risks, whether known or unknown. I assume full risk and responsibility for myself, my equipment, my horse and equipment. I have read and understand I expressly waive any rights I may have under California Civil Code 1542, which states: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor." I agree to indemnify and hold harmless Historic Nelson Ranch "HNR", it's owners, employees, agents and directors thereof, all and singular from and against all liability for injury, loss, costs or expenses or any claim thereof of whatever nature including court costs, actual attorney fees arising from any proceeding or law suits brought by or prosecuted for my benefit. This includes claims that I, my assignees, heirs distributes, guardians, next of kin, spouse and legal representatives now have or may have hereafter for injury or damage including horses and equipment resulting from participation in HNR activities.
